8th INTERNATIONAL SMILING CHILD FESTIVAL APRIL 2014 ISTANBUL

To whom It may concern,

The Spinal Cord Paralytics Association of Turkey has been organizing International Smiling Child Festival since 2006. Since then, approximately 2400 disabled and non-disabled children from 45 different countries have participated in the festival. Our aim is to draw disabled and non-disabled children of the world all together in order to provide cultural exchange between of them.

As The Spinal Cord Paralytics Association of Turkey, weplanto organize 8th International Smiling Child Festival in Istanbul which will be held in **April 2014**, **during 4 days (as planned)**with the participation of children, **ages between 7 and 15**, from all over the world. In this context, weask for disabled or non-disabled children who can carry outperforming arts like modern dance, folklore dance, lyrical dance or any kind of arts, can sing child songs etc. to attend our festival.

The attending group should consist of maximum 10 persons including maximum 3 companions (If it is a mental disabled children group, this number might be increased up to 12 in regards of extra companions). The children in the groups must be in the ages between 7 and 15. Due to the limited time schedule, the performances of the children group have to be maximum 10minutes.

The Spinal Cord Paralytics Association of Turkey will cover all the costs of festival participants related to the organization such as accommodation, food and beverage, local transportation in Istanbul. However, round-trip expenses (Cost of transportation to Istanbul and back), personal expenses such as gift shopping, and specific needs will not be covered by the organization!

The candidate groups, who have filled out the pre-application formcompletely and digitally (not hand writing) and uploaded demo videos of their performances to YouTube orwetransfer,can send their pre-application until 30.10.2013 to burak.keskin@tofd.org.tr with the title: "8th Smiling Child Festival – 'Organization Name &Country Name'".
